Content description:

<u>1794 to 1931:</u> Indexes arranged in A-Z order of first letter of surname or organization name. List surname/organization name, first name, "To" or "From" if appropriate for the document or document type, example: agree., bond, company, appr., etc., then other party, book #, page #. Document contents per type.

<u>1831 to 1979:</u> Index is "sequenced" by *indenting* the first letter of surname/organization name in chronological order. List date, name, given name or initials, page no. Book no. at top of page..
