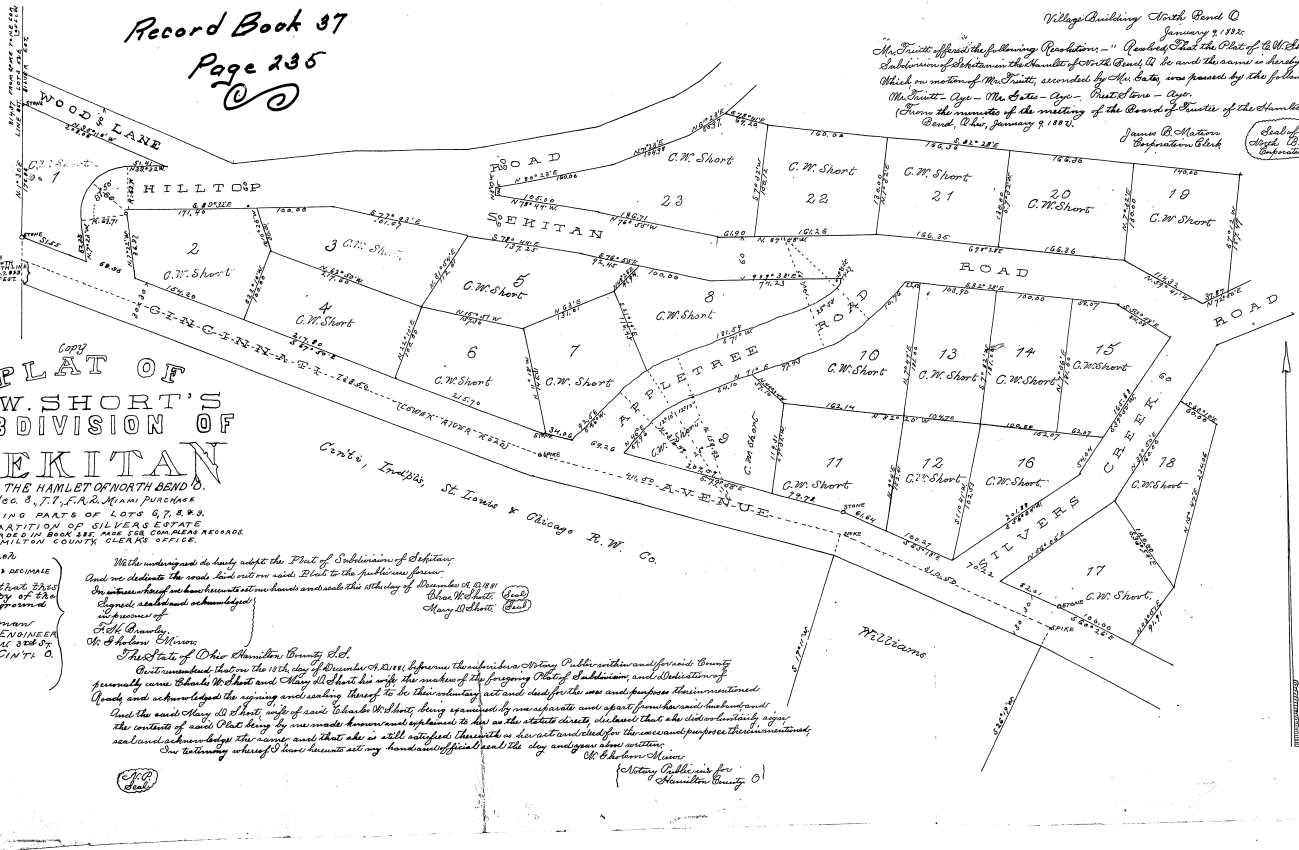
Village Building North Bend O.
