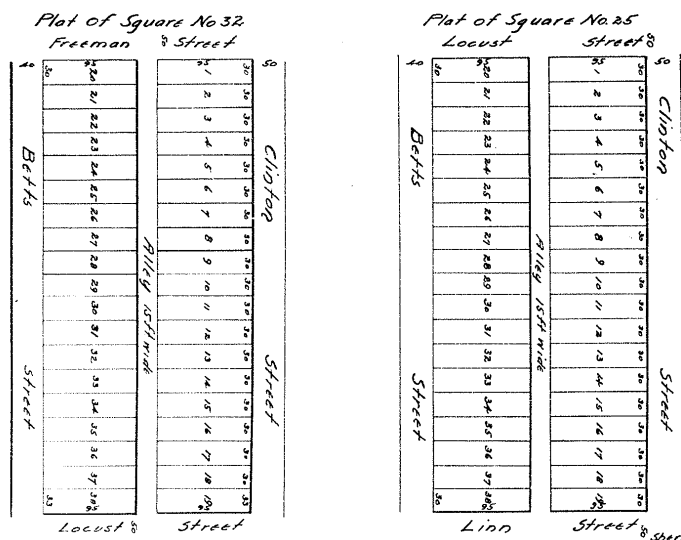
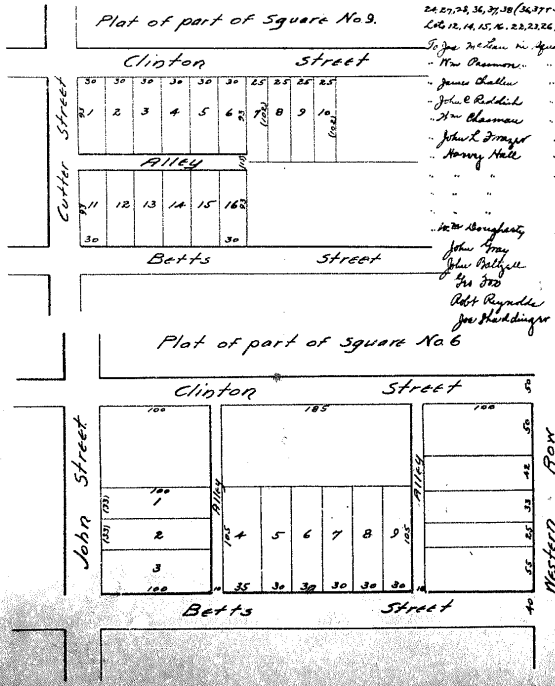

Plot of Lots in Squares 32, 25, 9 & 6 in Bett's Division made by the Sheriff.



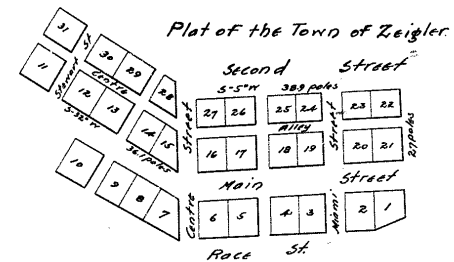

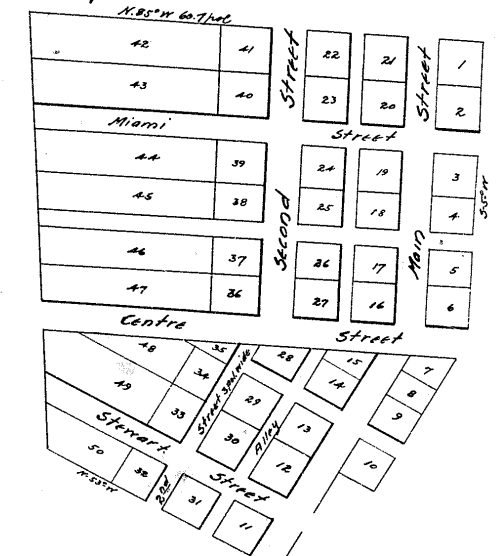
