

Vol 73 pp 296-301 (3rd Term 1839) Martha Ann and James Collins vs Eliza & John Wilcox v Colburn & Mary Sargent

Partition of 1) Lot in Colburn Park subdivision of lots as recorded in Book 49 p 529. Beginning on N. side of 4th street at a point 50 ft eastwardly on N. line of 4th st. 138 ft 10 inches to the western line of a lot designated in said subdivision as lot No 7. Thence northwardly with said line to a 20 foot alley, thence along the southern line of said ally 134 ft. 11 in northwardly, thence southwardly to place of Beginning.


2) Lot beginning on N. side of 4th st. at S.W. cor. of lot No. 7 in Subdivision made by line of Colburn Park. Thence eastwardly along N. line of 4th st. 33 ft 4 in running east Northwardly to an ally. This lot being conveyed to said trustees in common by Bonnegan, Charles wife, by Deed Recorded Book 58 page 594.

Lot off to Mary 1) Beginning at S.W. cor. of lot first described on N. side of 4th st. thence Northwardly with W. line of said ally 28 ft 9 in. thence Southwardly by a straight line to a point in N. side of 4th st. 40 ft eastwardly from the Beginning line to Beginning. 2) Beginning at S.E. cor. of the part of lot No. 7 described, thence Northwardly along 4th st. 9 ft, thence Northwardly parallel with E. boundary line of the property now divided, back to the said ally, thence Eastwardly along said ally off to the N.E. cor. thence along eastern boundary to Beginning.

To Mary Sargent: Beginning on N. side of 4th st. 10 in westwardly from S.W. cor. of said lot No. 7, thence running Eastwardly along N. line of 4th st. 25 ft 2 in. to S.W. cor. of strong lot, thence Northwardly parallel with eastern boundary of the property, back to the said ally, thence Westwardly along S. side of said ally 25 ft. thence Southwardly by a straight line to Beginning.

To Colburn & Sargent: Beginning on 4th st. 10 in Northwardly from S.W. cor. of said lot No. 7 running Northwardly measuring on ally, 47 ft 9 in. Northwardly by straight line, to a point on 4th st. 14 ft 10 in. westwardly from S.W. cor. lot No. 7 etc.

To Martha A. Collins: Beginning 47 ft. 10 in westwardly from S.W. cor. of lot No. 7, running Westwardly etc.



Vol 73 pp 301-305 (3rd Term 1839) Andrew and Providence White and Partition of tract known as Yellow Field. Tract area 29 T.R. Cont also w/ 10 acres/lot in N.E. cor. sec 30 5. S. R. 3 in lot no. 18. Elizabethtown, assigned to widow as her share. The brick house on lot 301 with 3 acres of ground around it. This 5 acre lot where the house stands etc. Assigned to Ulrich C. Woodbury & Phineas C. Woodbury also lot No. 18 Elizabethtown. Lots numbered on Plat for 1-5 include all of file sec 29 lot 20. Beginning at N.W. cor. of said lot, thence easterly with S. line 14 ft 7 in ch. thence S.E. 30' 26 1/2 ft ch. thence W. 1/2 line of lot 14 ft 7 in ch. then N 14° 30' W with W. line of lot 20 1/2 ft to place of Beginning. Lot No. 2 Beginning at N.W. cor. of lot 301 then with S. line of said lot 14 ft 7 in ch. then N 14° 30' 26 1/2 ft ch. to the Meridian, thence down same by its meanders to the point where the W. line of the sec. intersects the said River. thence N 14° 30' W with said meanders to place of Beginning. Lot No. 3 Beginning at N.E. cor. lot 1, running easterly to place of Beginning. At N.E. cor. of lot No. 3 running easterly, lot No. 5 begins at N.E. cor. lot 301 running easterly. The 5 acre lot attached to lot No. 1 in the N.E. cor. sec 30. Begins at the N.E. cor. of said lot, thence westwardly with the S. line 6 66 2/3 chains, thence 5 ft 30' 5 7/8 ch. thence easterly, 4 ft in line of the lot 6 66 2/3 to the Meridian, thence N.E. 30° 45' 7 1/2 ch. to place of beginning. The 5 a. lot attached to No. 5 has 5 of the above described lots & is bounded by lines bearing the same bearing and distance. Reported March 1, A.D. 1839.

Filed Aug. 15, 1817 Partition of Providence White to have off his undivided one fifth share off not 160 acres as immediately stated in his partition but 150 acres situated on the north side of section number seven in the third township and first sister range of which tract Andrew Smalley is tenant in common with him of undivided 1/5 parts. Decided with Rent 2 of Sec 7-5-6-2-1
