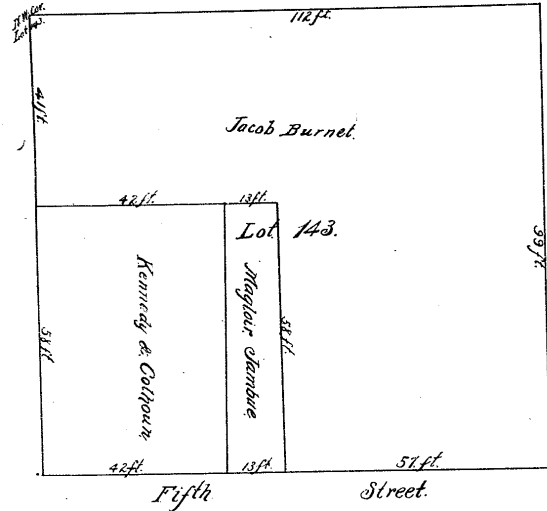


Pages 168-171 Petition of Jacob Burnet for Partition of part of Lot 143 General  
Plan of Commission between himself and Major James. November 1816

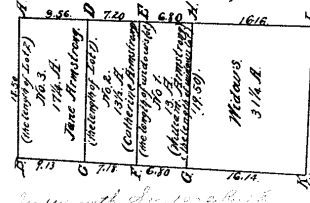

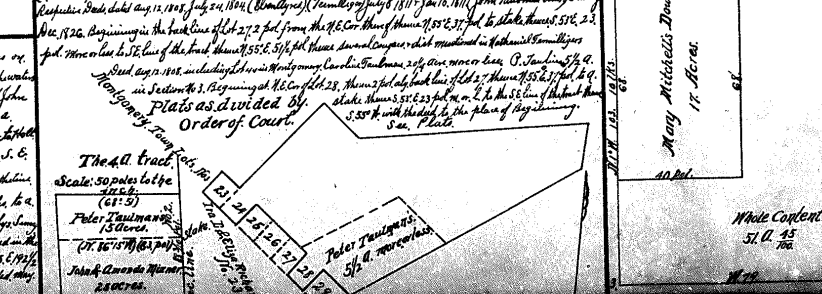
Pages 200-203 Partition of estate of Elizabeth Lamed, dec'd wif. 60 Acres in the Township of Columbia.
