W. sch. 62 1/2 acres situate in Clinton Webb's land, intersected by a Boundary bearing N. 61° 28' 28" W. thence due N. 46° 52' 00" to a corner intersected by another bearing N. 46° 14' 00" E. then N. 25° 48' 25" E. 25' 00" to the Beginning containing 15 acres 26 feet, bounded to the N. by John Webb (Book 101, page 353) Edward J. Tappin, George Sturpin & Aaron Tappin. The petitioners are the only surviving children of Philip Tappin & his other children, many deceased and unlocated without exact names. Robert F. Tappin died leaving a widow Frances Mary an infant child, which latter has since deceased and Philip P. Tappin left another family of 10 wives. The Commissioner having ascertain that Henry Tappin relinquished his right to recover that the petitioners were the persons entitled to the real estate situated in the town of Clinton Webb in the lots under 10th & 11th Street designated as lot 3, 5 & 11 in the plot returned to Court by the Commissioner as delineated in a suit in partition among the heirs of this Tappin died (Aug. 11, 1827) 33 acres 9 perches designated as lot No. 1 in the plot of land of the estate of P. P. Tappin & R. F. Tappin her heirs & trustees, and also lot No. 1 in said Plot including the remainder of the lot of P. C. Tappin and containing 33 acres 3 perches. Set off for Survey to Henry Tappin, lot No. 3 (33 acres) on the said Plot known as the estate of P. P. Tappin & R. F. Tappin her heirs & trustees, and also lot No. 1 in the accompanying Plot set off to both parties in common as third owner also the 8th item being the lot or Boundary between the two lots of Bumble streets.

Set off to G. Tappin lot No. 1 on Front street and lot No. 4 on Front street.



